Application Requirements



Mandatory Requirements for ELLA 2.0

1

Compulsory OCBC CASA Account

Must have an existing or a new CASA account with OCBC Bank for loan disbursement (TAT 24 hours). subject to completion of legal documentation process and payment of all fees (ie. Legal fee, insurance premium and/or any other incidental cost).

2

Direct Debit for Repayment

Compulsory to sign up for Direct Debit for loan repayment. 3

Keyman Insurance

Compulsory to purchase Keyman insurance (ETLA or Group PA) for all guarantors with Great Eastern General Assurance (cash purchase) 4

Legal Fees

Legal fees of RM1,200 per case to be paid by the customer. Legal attestation and video conferencing are managed by one of our panel law firms in KL.




